Year-end Dividend Forecast for the Fiscal Year Ending March 31, 2020

TOKYO, May 7, 2020 - Monex Group, Inc. ("the Company") announces that it forecasts the following payment of dividends for the Fiscal Year Ending March 31, 2020.

1. Background

The Company has calculated forecast of year-end dividends for FYE March 31, 2020 in consideration of share buyback and interim dividend during this fiscal year, and high performance in the second half of this fiscal year, with a target of a 75% total return ratio as a percentage of net income attributable to owners of the Company on a muti-year basis. As a result, the total return ratio of this fiscal year is expected to exceed 162%. Forecast of year-end dividend is stated in "2. Dividend Forecast per share".

* Total return ratio = (total dividends paid + total amount of share buyback) /net income attributable to owners of the Company
