## **Coincheck NFT (β version) to start offering MAYC on November 30**

Coincheck, Inc. (Head office: Shibuya-ku, Tokyo, President: Satoshi Hasuo, hereinafter Coincheck) announces that its NFT marketplace Coincheck NFT (β version) will begin handling Mutant Ape Yacht Club (hereinafter MAYC) on November 30, 2022 (planned).

MAYC is a generative NFT project launched in August 2021, and is an NFT issued as an affiliate NFT of Bored Ape Yacht Club (hereinafter BAYC), which has one of the highest transaction values on OpenSea, the world's largest NFT marketplace. A total of 10,000 NFTs featuring apes have been issued, each with a different appearance and characteristics.

Yuga Labs, the operator, has used the success of BAYC as a foothold to develop derivative NFT series such as MAYC and BAKC, as well as the Metaverse business, and is also planning to release the Play to Earn business in the future.
